The term "Fire Marshal's Office" also applies to law enforcement investigative divisions. Non-priority students (fire suppression, law enforcement patrol personnel or DoD fire personnel) do not need to obtain Chief's signatures. They are admitted into the class on a "first come-first serve" basis after the priority students are enrolled.</p>
