AGENCY REPORTS

Training and Operations

The Branch Chief for Training and Operations provided the following report:

- **Course/Class Delivery:** IFSAC conducted it on-site review of the agency in October. The meeting went well with some minor follow-up that has since been successfully addressed. Prior to this reaccreditation process, the agency was accredited for 6-levels of training. I am happy to report that through IFSAC, the VDFP is now accredited for 16-levels of training. The Pro-Board visit for reaccreditation is supposed to occur prior to the end of the year.
- **Staffing:** Consistent staffing at both the Division level as well as in Glen Allen continues to present some challenges. Since the last FB meeting, the Logistics Chief position has been filled as well as the FTE for the Administrative Assistant to both Division I and the T&O Branch Chief. Interviews for the vacant Division 5 AA were held last week
- **Initiatives**: Work continues on the Cornerstone Project with the agency going live (internally only) earlier this month. We are still working through some challenges with an expected live launch across the Commonwealth in early 2020. When fully implemented this will dramatically improve the work flow, course/school administration, and student

access to course/records. All users of Cornerstone will need a valid e-mail address. This is a requirement of the system and needed to register for use.

Due to the time required for implementing Cornerstone, several other projects have been held up. This is due to the fact that the Curriculum Developer has been tasked with the Project Lead for Cornerstone implementation and is currently filling that role as well as that of the System Administrator.

- **Division Offices:** The technology infrastructure at D-5 continues to be a challenge. Initial work has been done on an expected late spring relocation of Division 4 to the grounds of Western State Hospital. Work is being done on relocating Division 3 to the Lynchburg area of the Commonwealth. This will provide better accessibility as well as open the labor pool for a better recruitment of the long vacant Administrative Assistant position. Downsizing of Division 2 is moving forward with an estimated 30% reduction in footprint.
- **National Fire Academy, Virginia Weekend**: Was held on November 16 and 17 with just shy of 80 attendees. The classes presented included:
 - Health and Safety Program Manager
 - Incident Safety Officer
 - o Introduction to Unified Command, All Hazards
 - o Building Organizational Support for Community Risk Reduction

Going forward we are looking to establish a partnership with another state(s) to take advantage of greater course selection and student engagement. Virginia was the first state to attend in Federal FY 2021 (begins in October) se we are not eligible for another SWP until after October 2020.

• **VDFP Support:** VDFP has been asked to support the February 2020 Fire-Rescue Conference. The request is heavy on IT support and the agency is currently in the process of strategizing how to support the various conferences that make requests.

Risk Management Branch Report

- **Firefighter Cancer Awareness:** VDFP adjunct Steve Weissman presented our Firefighter Cancer Awareness Program at Fire Rescue International August 8, 2019 in Atlanta (@50 Students). The program was also delivered to The NOVA FD Leadership Development Institute (62 Students). We also delivered the full Cancer Prevention and Burn Prevention programs at The Virginia EMS Symposium in November (12 Students).
- **PPE for Instructors:** Most PPE has been distributed. We secured a contract for cleaning and maintenance according to NFPA Standards (Minerva). We are working through the first round of maintenance on the first round of gear issued. Working well, but collecting gear scattered across the state is still a challenge.
- **Live Fire Training:** I have started attending Live Fire Training across the Commonwealth. Checking on compliance with NFPA 1403 and our policies by our staff. Have a draft Live Fire Training Policy.

- Statistical Data: Please see below for statistical data for the injuries documented in our training programs Thus far in FY 2020. Our numbers are running parallel to what they were last year in numbers and type. The leading programs causing injury and the leading types remain unchanged and continue to be in the Firefighter Series Programs. Primarily Strains/Sprain type injuries lead with Exhaustion/overexertion type injuries right behind that. Physical conditioning would seem to be a primary cause for this. (See charts next page)



- The reaccreditation site visit was held on October 29th 31st for IFSAC. As a result of the visit we have been either reaccredited or received initial accreditation for the following levels:
 - o NFPA-1001 Firefighter I and II (Chapter 5 and 6)
 - o NFPA-1002 Driver Pump Operator (Chapter 5) and Driver Aerial (Chapter 6)
 - o NFPA-1003 Airport Fire Fighter (Chapter 4)
 - o NFPA-1005 Marine Fire Fighter (Chapter 4)
 - o NFPA-1031 Fire Inspector I and II (Chapter 4 and 5)
 - o NFPA-1033 Fire Investigator (Chapter 4)
 - o NFPA-1035 Fire Life Safety Educator I and II (Chapter 4 and 5)
 - o NFPA-1072 Hazardous Materials Awareness (Chapter 4)

- With the above stated we now have 16 levels accredited through IFSAC up from six previously which will allow us to provide students with accredited sealed certificates for those levels.
- We have prepared for the site visit for Pro-Board however we have not been provided the site visit date as of this report being finalized. We will add an additional 7 levels to the above list of certifications which will give the agency 23 levels of accreditation overall.
- All new testing has been developed and will be implemented in January 2019 throughout the Commonwealth.
- The staff has been part of the Cornerstone on Demand work group and are preparing for the launch of the new system in January.

- We are currently working to closeout all of the training programs in FSTRS and provide certification to each student who has earned that certificate. Our goal is to finalize this effort by the end of January 2020.
