<u>Session #44122004 - Basic Pump Operations</u> <u>Sat. 9/11/21 & Sun. 9/12/21</u>

Description: A course designed for new operators with emphasis on hands-on operation of pumpers at draft and from hydrants, and relay operations.

Prerequisites: None

Equipment: Helmet, gloves, and hard toe shoes. Departments sending students are strongly encouraged to send apparatus, if possible.

Session #44122003 - Hazardous Material Operations Sat. 9/11 & Sun. 9/12 ~ Sat. 9/18 & Sun.19 ~ Test Sat. 10/9

Description: This course is a training component in a systematic approach to Hazardous Materials Emergency Response Training. This version of HMA&O course incorporates both Awareness-level knowledge and Operations-level knowledge and skill to prepare emergency responders for hazardous materials emergencies. The HMA&O program includes training at the Awareness-level to meet the expectation found in OSHA and NFPA.

The purpose of the HMA&O course is to develop the knowledge and skills of emergency responders so they are able to safely and effectively operate at a hazardous materials incident. The program has been designed to meet the training needs of responders to function at the DEFENSIVE operational level. Current federal regulations and professional standards found in OSHA and NFPA are the framework of this program. The development of the HMA&O course was based on acceptable safe and effective practices for defensive tactical control of hazardous materials emergencies.

<u>Session #44122005 - Instructor I - DATES HAVE BEEN REVISED</u> Sat. & Sun. 9/11, 9/12, 10/3, 10/9, 10/16, 10/17 - Testing 10/30/21

Description: This course is based on NFPA 1041, Standard for Fire Service Instructor Professional Qualifications, and leads to a Pro Board certification. The course is designed for individuals who want to develop the knowledge and ability to deliver instruction effectively from a prepared lesson plan, including instructional aids and evaluation instruments; adapt lesson plans to the unique requirements of the students and the authority having jurisdiction; organize the learning environment so that learning is maximized; and meet the record-keeping requirements of the authority having jurisdiction.

Prerequisites: Firefighter II, Hazardous Materials – Awareness & Operations **Equipment:** None

<u>Session #44122006 – FFI & FFII – Train-the-Trainer</u> Sat. 9/11 & Sun. 9/12

Description: Firefighter 1 & 2 train the trainer provides the guidance necessary for delivering a quality Firefighter 1 & 2 (NFPA 1001-19) edition programs. The material covers the Administrative Guidelines for Firefighter 1 & 2, overviews the two (2) approved curriculums, reviews the resource package, and the classroom and practical material as well as review of testing procedures. During the train the trainer, the process for new candidates shall be clearly explained and includes time to answer questions related to this program delivery. All candidates must attend 100% of this program.

Prerequisite: Passing of Pretest is required. Firefighter II, Hazardous Materials Awareness & Operations, and Fire Instructor I. Pre-test can be scheduled in any Division office.

<u>Session #57122033</u> - <u>Surface Water I & II</u> <u>Fri. 9/10, Sat. 9/11 & Sun. 9/12</u>

Description: This program is designed to introduce students to the basic principles of surface water rescue of victims in confined water or water whose movement is less than 1 knot. Students will receive training in planning the response, proper PPE selection, information gathering, reach and throw rescue techniques, boat assisted rescue and recovery techniques and personal survival/self-rescue skills. Students will be expected to demonstrate survival-swimming skills with the use of a personal floatation device as part of the class

Prerequisite: Knowledge of proper use of PPE and SCBA Equipment Required: Wet suit and appropriate swim attire Student Materials: VDFP/VDEM Student Manual. **Printable on the Virginia Learning Center** Hours: 32 (Not including testing)

57122035 - Introduction to Technical Rescue MODULE II Sat. 9/11/21 & Sun. 9/12/21

Description: This training provides a foundation to prepare students for a wide variety of possible rescue operations based on objectives from NFPA 1006 Standard on Technical Rescuer Professional Qualifications, and NFPA 1670 Standard on Operations and Training for Technical Search and Rescue Incidents.

Module 2 is a 16-hour introductory classrooms and practical program addressing job performance requirements of NFPA 1006. This program covers basic rescue skills in low angle environments, victim packaging, rope, knots, anchors, lowering systems, and haul systems. This program is designed for personnel who will support technical rescue incidents. Students will receive a VDFP Certificate of Attendance. Students must be 18 years of age prior to attending.

Prerequisite: Completion of ITR Module 1 and 2 are pre-requisite for all Virginia Department of Fire Programs Heavy and Technical Rescue courses.

Equipment required: helmet, rescue harness, tight fitting gloves **Hours: 16**

57122034 - Vehicle Ops I Sat. 9/11/21 & Sun. 9/12/21

Description: This program meets or exceeds the requirements for NFPA 1006 Standards for Technical Rescuer Professional Qualification, Chapter 10, Level 1. The students will learn to perform at the Operations Level as specified in NFPA 1670, Standards on Operations and Training for Technical Search and Rescue Incidents, Chapter 8.

This 16 hour program includes classroom and practical training in Common passenger vehicle anatomy, systematic approach to vehicle rescue incidents, common passenger vehicle stabilization, incident hazard isolation, access and egress of common passenger vehicles, disentanglement of victims, the packaging and removal of victims for a common passenger vehicle, and operating as a member of a rescue team and directing rescue operations.

Equipment required: helmet, tight fitting gloves, eye protection, boots and ankle protection.
