PUBLIC COMMENT

Greg Hunter a Deputy Chief with Fairfax County came before the board to discuss a couple of items for them to look at. The first item was that Fairfax is a delegated authority and he discussed that processing pro-board applications are around \$10,000. If Fairfax could go through VDFP purchasing with the discounted rates and process the seal as they currently do with IFSAC they would be at around 20% the cost at around \$2000. They are suffering from low staffing and hiring processes and certified individuals. He asked that the agency look at and revisit the process to integrate the pro-board certifications 2nd option to ask the board to move forward with cornerstone which is currently a hindrance within his organization. He has worked with some VDFP staff on the implementation. Access for training centers and training staff is on the future blue print but VITA is controlling our ability to move forward. He believed that the 5-10 year implementation plan needs to be reassessed.

Keith Johnson spoke that the Virginia Fire Chiefs have commissioned a letter with similar concerns to Mr. Hunter. That letter was not ready for this meeting but will be coming in the near future. The letter will be shared with the board members and VDFP Staff to take action.

Garrett Dyer asked for Mr. Hunter to provide his request in writing so that the agency could properly address the concerns. Since there were multiple concerns the agency wanted to emns8ure that all were captured.
