   1 for further detail.
- Emergency/Critical Repairs: They are defined as rendering the apparatus/vehicle inoperable or unable to meet its intended use.
   Routine maintenance and repairs are not included.

# **Appeals Process**

Edits cite;

- All Board members shall be copied on the Agency's provisional correspondence if the Agency determines the ATL usage request does not meet the intent of the COV §38.2-401 and the ATL Policy.
- Localities may appeal the Agency's provisional decision(s) about the allowable use of ATL funds to the Virginia Fire Services Board.
- It is incumbent on the locality to appear before the Virginia Fire Services Board to appeal their request(s).
- New Paragraph: The Agency will develop a tracking database to capture all denials by fiscal year. The denials tracking database will be provided to the Virginia Fire Services Board at the conclusion of each fiscal year.

# **Topic: Burn Building Grant Program Policy**

**Topic Discussion:** The subcommittee reviewed the modifications made to the Burn Building Policy by the Policy Workgroup. Additional amendments were made. New content is reflected on the enclosed Burn Building Policy Document. **[Enclosure 2]**

#### <u>Section E – Burn Building Subcommittee</u>

• **New Content:** The Burn Building Subcommittee will report to the Full Virginia Fire Services Board and will be a full standing "committee" of its own.

# <u>Section F – Definition of Terms, Engineering/Architect (E/A) Fees</u>

 New Content: Burn Building Grant will provide up to \$50,000 for projects as opposed to its original amount of \$10,000. All areas citing \$10,000 has been changed to reflect this.

## Section G – Disbursement of Funds

• Edits for # 5 cite; Repairs shall be evaluated by the Agency in the order in which they are received, and if a request for funds meets the requirements then it shall be

funded up to \$50,000 or the remainder of the funds in the account if less than \$50,000.

## <u>Section H – Grant Application</u>

• Edits cite: Emergency Renovation modified to "Emergency Repairs."

## <u>Section K – Extensions</u>

• **New Content:** An extension of up to 90-days or the next regularly scheduled Virginia Fire Services Board meeting may be granted by the Agency.

## <u>Section R - Permanent Burn Buildings Inspections Requirements</u>

• **New Content:** For the fifth year of inspection, the Agency's A/E Firm will satisfy the inspection for that year (i.e. Locality will not have to conduct its own inspection.)

The updated policy will be effective on January 2016.

# **Topic: Regional Fire Services Training Grant (RFSTG)**

#### Section F - Eligible Regional Fire Services Training Props.

- A recommendation was made to modify the first statement that provides background on this section to as follows;
  - New Content: This is not an all inclusive list and the Virginia Fire Service Board will consider applications submitted requesting training props not listed in this policy. Please be aware if applying for a training prop not identified in this policy all requirements listed for the submission of a grant application will still apply to these training props.

# **Section L - Maximum Amount**

• **New Content:** Modification cites that a jurisdiction submitting a grant application may submit one application containing multiple training props but are only allowed to receive a maximum award of \$50,000.

The updated policy will be effective as of January 2016.
