- A. Review of On-Going Live Fire Training Structure (Burn Building) Building Grants Fluvanna Hanover County Suffolk County
- Fluvanna County: on second round procurement solicitation. Bid with the County attorney since November. Have received 4 extensions
- Scott County: complete 98%

- Suffolk City: no update but not required to report until after the building permit is submitted.

- B. Burn Building Repair Grant Request FYI Only
- Virginia Beach awarded 53% of requests totaling \$34,549 to address issues identified in their internal inspection.
- Lynchburg City awarded 69% of their request totaling \$38,849 to address issues outlined in the 5 year inspection
 - C. Discussion on Live Fire Structures Policy
 - i. Timeline for Projection Completion / Maximum Project Extensions

 Topic Discussion: Committee discussed the increasingly strained commodities and contingencies based on the current policy. Pittinger informed the committee they could put in certain language to state there could be a reapplication process if commitment has not been met. Sites discussed the opportunity to provide a milestone checklist that localities can use to benchmark their completion.

 Cotton requested a list of challenges Fluvanna met. Planning is critical for the benchmarking moving forward. Agency can come up with steps to meet and incorporated into policy.
- D. Discussion of Delinquent Annual Inspections
 Review of the information provided to committee. No additional discussion on this
 item. Division Chiefs have a done a great job in reaching out and providing
 encouragement that the annual inspection reporting is required for funding. What
 happen: No buildings have been taken off the certification list. This is a new process in
 two years of infancy. VDFP believes suspending sponsored training in these delinquent
 Should cease that the continued point of contention. Roanoke County identified there is
 an appointment scheduled and identified. Bedford County identified there was a
 completed inspection. Cold buildings are removed from the list. Sites what is VDFP's
 expectation on this information by the time we meet again for this information. VDFP
 defined the expectations of completion deadlines.
